Privay Policy

This privacy policy ("Privacy Policy") is the commitment of PT. This Privacy Policy includes the following matters:

1. Personal Information we collect

We request information deemed necessary when you register an account to be able to use and access the Platform, including, but not limited to your personal data such as your full name, company, email, contact number, password, B-Pin, your role, Risk Profile including : Placing Number, Risk Name, Insured, Class of Business, Deadline, Risk Details including : Interest Detail, Total Sum Insured, Rate Premium, Total Premium, Available Share, Period of Insurance, Underwriting Information, Upload Document including : Placing Slip, Claim History (if any), Survey Report, Letter of Appointment, Other Document, Risk Setting including : Security List (hide/show), Publication (private/public), Proposed Premium, Proposed Share, Placing Confirmation, Subjectivity, internet protocol address, device activity information, browser type, date and time of request, referral URL, operating system, and page statistics views and other information that will be useful or necessary ("Personal Data") to provide you with our best services from the Site. Through the use of the Platform, We collect, process, analyses, and store Personal Data in the following ways:

- a. Personal data/information which submitted independently and voluntarily by you, including but not limited to when you :
 - 1. Create an account to be able to use and access the Platform;
 - 2. Placing Sisk(s) and Underwrite Risk(s)
 - 3. Give us feedback(s) by email, form, letter or phone;
 - 4. Whenever you use the Platformn or visit our Website, we may collect certain technical data concerning your usage such as, internet protocol (IP) address, information as web pages previously or subsequently viewed, duration of every visit/session, the internet device identity (ID) or media access control address, and also information regarding the manufacturer, model and operating system of the device that you use to access the Platform and/or our Wenbsite.
- b. data that we obtain through social media, including but not limited to, like our Fan Page on Facebook; interact with us through other social media sites such as Instagram, Youtube and/or Linkedin.
- c. Data recorded when you use the Website and Platform, including but not limited to when you visit the Site, for which we can process technical data such as your Internet Protocol (IP address).

2. The use of Personal Information

Your Personal Data is used and protected by the Company in accordance with the Applicable Legislation and this Privacy Policy. The Company collects User information with the following objectives:

- d. - b. We divert practices related to the collection, storage and handling of information, including technical and physical security measures, to protect the system from unauthorized access.
- c. With regard to the provisions of Article 3, we discuss accessing Personal Data only to our employees, contractors, agents who need to know the Personal Data, or who are related to the agreed confidentiality agreement, as well as other related parties that stipulate the provisions regarding this privacy policy.
- d. We take technical, mandatory, and administrative steps designed to protect your Personal Data. We ask for physical, electronic and procedural safeguards relating to, storing and disclosing your Personal Data. Our security procedures require us to request verification of your identity before we disclose Personal Data to you. You are also responsible for the security assistance of your Personal Data such as for never giving a password to a third party, and for leaving your account after you have finished using the Site.
